\checkmark	Agrees that FRO may inspect donations upon self-haul/pickup.		
V	Agrees that either Donor and/or FRO document donation items, including amount, weight, types of food, expected duration of food freshness, and any other notable information/updates, and maintain records, <i>including products donated in pounds per month for a minimum of three years</i> , and/or transfer records to either party upon request at any time.

\checkmark	Assign staff member(s) to communicate and assist FRO within 20 minutes of its self-haul or arrival at the drop-off/pickup window.

FRO Service Agreement Terms: 1. FRO agrees, to the best of their ability, to do the following: \checkmark Accept approved/inspected donated edible food for distribution. Ensure FRO staff picking up donations are trained in safe food handling. Ensure all donations are in original, sealed packaging and stored in food-grade \checkmark containers in accessible, food-safe areas before the pickup window begins. Acknowledge and begin assisting the Donor within 20 minutes of its self-haul or arrival \checkmark at the drop-off/pickup window and maintain the prearranged schedule of arriving on time. Wear easily recognizable clothing and/or identification. Use active or passive (thermal blankets and/or coolers) temperature control while transporting perishable donations. Agree that either Donor or FRO document donation items, including amount, weight, types of food, expected duration of food freshness, and any other notable information/updates, and maintain records for a minimum of three years and/or transfer records to either party upon request at any time. Ensure that FRO inspections of Donor donations are completed with utmost care and \checkmark transparency, with any concerns being expressly communicated to the Donor. Other:

This Agreement shall become effective as of the Effective Date and continue in full force and effect until terminated by either Party. This Agreement shall be governed by and construed by the laws of the State of California and applicable federal law, including, without limitation, the Bill Emerson Good Samaritan Food Donation Act and the State of California Good Samaritan Food Donation Act – which establishes Federal and State protection from civil liability for persons involved in the donation and distributions of food and grocery products when specific criteria are met, so long as donations are set in 'good faith.'
